

The Offshore Safety Professionals Membership Criteria

For the purpose of these Criteria, the term “Offshore Related Role” also applies to onshore safety roles which support the offshore operation.

BOSIET/FOET, Offshore Medical and MIST (if applicable to working environment) are to be in place if applying for offshore positions through The Offshore Safety Professionals Register (OSPR)

Demonstrable experience in certain fields is as valuable as a certificate of competence from a training provider; this will be assessed on application and may require further interview.

All ‘MyOSPR’ profiles submitted for review are subject to formal assessment by OSPR’s Managing Members.

* **Internal/External Auditor*** - Auditor qualifications will ideally cover any ISO standard (e.g. 9001, 14001, 18001). However, any other training courses regarding the auditing process will be assessed on an individual basis.
